Enquiries about results and assessment decisions

A fee will be charged for an enquiry about results and assessment decisions, or a review of moderation. If the outcome results in a change to a grade, the fee will be waived.

Clerical check (per batch)	£5.00
Review of marking with report (only chargeable if grade not changed)	£50.00
Review of external quality assurance decisions (per enquiry)	£249.50
Review of moderation (only chargeable if grade not changed)	£728.00

Appeals

A fee is charged for an appeal. If the appeal outcome is not in favour of the appellant, we will invoice the correct fee as per the below.
